### SCHOLARSHIP APPLICATION RULES



Ozark Federal Credit Union will award up to three \$1,000 scholarships each year. To qualify for the OFCU scholarship, applicants must meet the following criteria: they should be active and in-good-standing member of OFCU, with a clear intention to enroll in an eligible institution. Eligible options include trade schools, vocational institutions, as well as accredited two or four-year brick-and-mortar or online colleges or universities in the United States.

#### ELIGIBILITY

- 1. Must be a member of Ozark Federal Credit Union with all accounts in good standing for at least 12 months. A member in good standing is defined as one with an active checking account and no loan delinquencies. Membership is open to any of the following individuals:
  - Anyone who lives, works, worships, or attends school in the following counties: Bolinger, Butler, Carter, Cape Girardeau, Dent, Douglas, Dunklin, Howell, Iron, Madison, Mississippi, New Madrid, Oregon, Ozark, Pemiscot, Perry, Renolds, Ripley, Scott, Shannon, St. Francois, St. Genevieve, Stoddard, Texas or Wayne.
  - o Immediate family members, of existing Ozark Federal Credit Union members (parents, spouse, children, siblings, grandchildren, grandparents, aunt, uncle, niece, nephew, first cousin, or legal guardian).
- 2. Ozark Federal Credit Union Board of Directors, employees, and dependents are not eligible to participate.
- 3. Students who live, work, worship, or go to school in the following Missouri Counties: Bollinger, Butler, Cape Girardeau, Carter, Dent, Douglas, Howell, Iron, Madison, Mississippi, New Madrid, Oregon, Ozark, Pemiscot, Perry, Reynolds, Ripley, Scott, Shannon, St. Francois, St. Genevieve, Stoddard, Texas and Wayne. Eligibility also includes a spouse, parent, step-parent, grandparent, grandchild, child, sibling, or a person who shares a residence with an existing member.
- 4. College-bound student accepted or enrolled as an undergraduate student (for at least 6 credit hours per semester) for the 2024-2025 school year at an eligible, trade school, vocational institution, as well as accredited two or four-year brick-and-mortar or online colleges or universities in the United States.
- 5. Students must have a GPA of at least 2.7 on a 4.0 scale to be eligible.
- 6. If under 18 years of age, the parent/guardian must be aware that the student is registering for this scholarship and will be available to accept the prize on the student's behalf, should the student become a scholarship winner.
- 7. The application must be submitted by July 3, 2024.

#### WHAT IS NEEDED TO APPLY

- 1. Certified copy of the applicant's high school/college transcript.
- 2. Complete the Community Involvement worksheet.
  - o academic awards/achievements
  - o extracurricular activities
  - church involvement
  - o employment
- 3. A copy of the acceptance letter from the post-secondary school the student plans to attend.
- 4. A 2-page essay, double spaced, not to exceed 750 words on the topic of "What are the best pathways for financial institutions to reach the underserved populations in your community?"
- 5. Please do NOT include any photos with your application.

#### SELECTION PROCESS

Ozark Federal Credit Union Scholarship Committee will consider the following criteria to select the scholarship recipients:

- Academics Transcript and GPA 25%
- Community Involvement & Employment (jobs and volunteer work) 20%
- Honors / Award (academic, extracurricular, and civic honors and awards) 20%
- Essay 15%
- Activities and Organizations (scholastic, extracurricular, and civic organizations) 10%
- Positions of Leadership 10%

Identities of applicants will remain confidential to the scholarship committee before a recipient is selected.

#### YOUR APPLICATION WILL NOT BE CONSIDERED IF IT IS:

- 1. Late Application and supporting documents must be received by July 3, 2024.
- 2. If the essay is handwritten the essay MUST BE TYPED.
- 3. Incomplete No applications will be accepted without ALL supporting documents. Incomplete applications will be filed with no action taken.
- 4. Unqualified Applicants must meet ALL of the eligibility requirements (see above).

### SCHOLARSHIP APPLICATION RULES



#### RULES FOR MAINTENANCE OF SCHOLARSHIP

- 1. Students must provide Ozark Federal Credit Union with a college transcript each semester for review to determine if eligibility has been maintained. A minimum of a cumulative 2.7 GPA on a 4.0 scale must be upheld for continued scholarship assistance. If a cumulative 2.7 GPA is not met, the student will be placed on a probationary period for one semester. If the cumulative 2.7 GPA is not achieved after the probationary period, the scholarship will be rescinded.
- 2. In the event the student is involved in disciplinary action with their college or law enforcement, the scholarship committee with review the matter to determine if the scholarship will be extended or rescinded.
- 3. Scholarships are for one year and are not renewable. Students must complete the semester with a minimum cumulative 2.7 GPA to receive the scholarship. \$500 will be awarded at the end of the fall semester and \$500 will be awarded at the end of the spring semester.
- 4. Award checks will be made payable to the educational institution.
- 5. Scholarship recipients agree to the promotional use of their likeness without additional compensation.
